NATIONAL QUALIFICATIONS FRAMEWORK ACT, 2008 (ACT NO. 67 OF 2008)

**DIRECTIVE ON THE IMPLEMENTATION AND TRANSITIONAL ARRANGEMENTS FOR PRE-2009
QUALIFICATIONS (UNDER SAQA ACT, 1995)**

I, Bonginkosi Emmanuel Nzimande, Minister of Higher Education, Science and Innovation, in terms of sections 3(2) and 36 of the National Qualifications Framework Act, 2008 (Act No. 67 of 2008) (NQF Act), considered advice from the South African Qualifications Authority (SAQA) and the Quality Council for Trades and Occupations (QCTO), and hereby publish the *Directive on the Implementation and Transitional Arrangements for pre-2009 Qualifications* (under SAQA Act, 1995 (Act 58 of 1995)).

MINISTERIAL DIRECTIVE ON IMPLEMENTATION AND TRANSITIONAL ARRANGEMENTS FOR PRE-2009 QUALIFICATIONS (UNDER SAQA ACT, 1995)

1. Background

- 1.1 The South African Qualifications Authority (SAQA) Act (Act 58 of 1995) provided for the eight-level National Qualifications Framework (NQF). Unit standard based qualifications, unit standards and qualifications not based on unit standards were registered at various levels on the eight-level NQF. The SAQA Act was repealed in 2008 and replaced by the National Qualifications Framework (NQF) Act (Act 67 of 2008). The NQF Act provides for a ten-level NQF with three distinct sub-frameworks with a quality council responsible for the development and quality assurance of its specific sub-framework. Each sub-framework developed its sub-framework policy that identifies the qualification types to be registered at each level of the NQF.
- 1.2 The NQF Act (2008), in section 36, makes allowance for transitional arrangements between the SAQA Act (1995) and the NQF Act (2008).
- 1.3 The Ministerial Determination in 2012 indicated that all qualifications registered on the eight-level NQF will not be re-registered and must be replaced with qualifications as per the sub-framework policies. All pre-2009 qualifications allocated to the Occupational Qualifications Sub-Framework (OQSF) were to reach their registration end date on 30 June 2015. The Quality Council for Trades and Occupations (QCTO) requested extension until 30 June 2018 as it was a newly established council, and not enough occupational qualifications were developed to replace the pre-2009 qualifications, at the time. The QCTO thereafter requested the re-registration of the pre-2009 qualifications until 30 June 2023 to allow for the development and implementation of the new occupational qualifications.
- 1.4 In 2020, the Minister of Higher Education, Science and Innovation published implementation and transitional arrangements for all pre-2009 qualifications (Under the SAQA Act, 1995) in a Determination of the sub-frameworks that comprise the National Qualifications Framework (Notice number on 1391 on Government Gazette No. 44031 published on 24 December 2020).
- 1.5 Sections 12 to 15 state:
 - a) The registration end date for pre-2009 qualifications and unit standards registered on the OQSF shall be 30 June 2023;
 - b) The last date of first-time learners enrolling for pre-2009 qualifications and unit standards registered on the OQSF shall be 30 June 2024;
 - c) The last date of achievement for learners enrolled for pre-2009 qualifications and unit standards registered on the OQSF shall be 30 June 2027; and
 - d) The Quality Councils must ensure that the accreditation period for the pre-2009 qualifications coincide with the ministerial determination.

- 1.6 In addition, the revised OQSF policy was published in 2021, identifying 9 occupational qualification types from NQF level 1 to 8. The policy states that all occupational qualifications registered on the OQSF must be reviewed and aligned to the qualification types as stated in the OQSF (2021).
- 1.7 A total of 1 475 pre-2009 qualifications reached their registration end date on 30 June 2023. The last date of first-time learners enrolling for pre-2009 qualifications and unit standards registered on the OQSF is 30 June 2024, less than 2 months from the date of this gazette. It was however found that a number of pre-2009 qualifications have not been prioritised by the SETAs for review and alignment to the OQSF policy (2021).
- 1.8 Although SETAs have been well informed of the transition since the establishment of the QCTO in 2009; have been specifically engaged to replace qualifications since 2018 (towards the 2023 expiry); and have been instructed by the Ministerial determination in 2020; they have not all adequately taken up this function.
- 1.9 Against this background, and after considering advice from SAQA and the QCTO, this directive amends the implementation and transitional arrangements for pre-2009 qualifications (under the SAQA Act, 1995) and puts in place a structured process to track and support the full implementation and transitional arrangements within the short to medium term.

2. Authorisation

- 2.1 This Directive is issued by the Minister of Higher Education, Science and Innovation in terms of sections 3(2) and 36 of the National Qualifications Framework Act, 2008 (Act No. 67 of 2008) (NQF Act).
- 2.2 This Directive replaces the published implementation and transitional arrangements for all pre-2009 qualifications (Under the SAQA Act, 1995) in the Determination of the sub-frameworks that comprise the National Qualifications Framework (Notice number on 1391 in Government Gazette No. 44031 published on 24 December 2020).

3. Commencement

This Directive takes effect on 1 June 2024.

4. Scope of the Implementation of Transitional Arrangements of pre-2009 Qualifications

Annexure A outlines the scope of the challenge in implementation and transitional arrangements for pre-2009 qualifications as well as the directives for implementation.

5. Implementation and transitional arrangements for pre-2009 qualifications

The following directives will be implemented related to implementation and transitional arrangements for pre-2009 qualifications:

- 5.1 No blanket extensions will be considered.

- 5.2 Deregister 1 101 pre-2009 qualifications and unit standards (in rows 1a, 2 – 5 of the table in Annexure A) based on the following:
- i. Replaced by registered occupational qualifications, part-qualifications and/or QCTO approved skills programmes;
 - ii. Dormant qualifications and pre-2009 qualifications that need not be realigned as confirmed by SETAs in consultation with industry;
 - iii. Provider based qualifications that are no longer relevant; and
 - iv. Insufficient motivation for extension.
- 5.3 Extend the last date of enrolment for 374 pre-2009 qualifications (1b, 6 – 7; marked in grey of the table in Annexure A) for a minimum of 1 year and a maximum of 2 years for qualifications that are in the process of realignment, development, evaluation and recommended to SAQA for registration. Reasons to extend learner enrolment are:
- i. Linked to regulatory qualifications (2 qualifications requested by the Minister of Finance);
 - ii. As confirmed by SETAs in consultation with industry, these qualifications in the QCTO realignment, evaluation and SAQA registration process; and
 - iii. Linked to instructional offerings of NATED Report 191 Part 2 - N4-N6 Programmes and N Diplomas.
- 5.4 The DHET and QCTO must engage to explore modalities for implementing Occupational Qualifications in TVET Colleges.
- 5.5 The listed trades where artisanal occupational qualifications have not yet been registered will be allowed an extension of a minimum of 1 year and a maximum of 2 years to allow training and development trade standards to be utilised to qualify artisans in such trades. [For information, there are 125 listed trades and 74 of these trades have occupational qualifications registered. SAQA, QCTO and the DHET note that artisanal occupational qualifications will be developed for the outstanding 51 listed trades].
- 5.6 The Pre-2009-unit standards that have been used for regulatory programmes will continue to be recognised provided that they are realigned through the QCTO as occupational skills programmes to replace the regulated unit standards.
- 5.7 SAQA, QCTO and DHET will report to the Minister of Higher Education, Science and Innovation on the SETA implementation in relation to their qualification development and replacement of the 374 pre-2009 qualifications.
- 5.8 SETAs are accountable for finalising the development and replacement of occupational qualifications.
- 5.9 SETAs will submit development plans and commit resources to the implementation of this transition to occupational qualifications.
- 5.10 DHET will contract and monitor the development of these occupational qualifications in the SETA Service level agreements (SLAs);
- 5.11 Ministerial instruction will be given for funding arrangements.
- 5.12 QCTO has the authority through SLAs with SETAs to hold SETAs accountable for delegated quality assurance functions.

5.13 The DHET, SAQA and QCTO will conduct a series of roadshows to capacitate SETAs, TVET Colleges and others.

6. Conclusion

6.1 These arrangements are not a collapse of the education and training system, but rather relates to 374 of the almost 9000 qualifications registered on the NQF (approximately 4%).

6.2 These arrangements only link to 18 of the 21 SETAs, (85%) who should be working closely with the QCTO and SAQA to ensure transition.

6.3 These arrangements are part of a process to transition into new, relevant occupational learning that develops appropriate skills for the current context, which has arguably changed significantly since the pandemic in 2020.

6.4 None of these objections to the expiry of pre-2009 qualifications are educational issues and should therefore be dealt with in other spaces.

6.5 No learner will be prejudiced if the system implements a managed transition away from qualifications that are now over 15 years old. On the contrary, learners may finally be given access to learning that is current and of high quality.

Annexure A – Current Process and Scope of the Challenge

SAQA, QCTO and DHET worked collectively on the identification, mitigation and monitoring of the implementation of the transitional arrangements for pre-2009 qualifications.

Through the QCTO, the SETAs have been consulted to confirm the information and co-craft mitigation strategies.

A total of 1 475 pre-2009 qualifications reached their registration end date on 30 June 2023. The last date of first-time learners enrolling for pre-2009 qualifications and unit standards registered on the QQSF shall be 30 June 2024.

The following table outlines the scope of implementation of the transitional arrangements for the pre-2009 qualifications and the way forward.
